



2017 Ralph B. Canterbury Scholarship Requirements

Paper applications will be accepted. Online applications preferred.

- Ten (10) scholarships will be available in the amount of \$1,000 each.
- Scholarships will be awarded at this year's Annual Meeting on Saturday, June 24, 2017 at Clearview's Main Office in Moon Township, Pa.
- All applicants must be members in good standing. Applicant must be the primary member on the account.
- Applicants must be applying to or enrolled in an accredited undergraduate or graduate program at a college, university or educational institution (minimum of 12 credit hours per semester for undergraduate and minimum of 6 credit hours per semester for graduate programs) during the fall semester of 2017 to be eligible.
- Employees, Board Members, Supervisory Committee Members and Scholarship Committee Members of Clearview FCU are not eligible.
- Immediate family members of Clearview FCU Board Members, Supervisory Committee Members, Scholarship Committee Members and Management Employees at the level of Director or above are not eligible.
- Immediate family members of all other Clearview employees are eligible provided the applicant meets all other qualifications.
- Previous Ralph B. Canterbury Scholarship winners are not eligible.

Requirements

- Completed application
- A statement of personal goals (100 words maximum)
- An essay on "Why I choose to belong to Clearview FCU" (250 words maximum)
- Your completed Activities and Community Involvement form
- Official transcript from your high school or college (whichever is applicable). Transcript needs to include the following to be considered official:
 - Printed on official transcript paper
 - Imprinted with the School Seal or Registrar's Signature
 - In a signed/sealed envelope directly from the issuing office
