CLEARVIEW FEDERAL CREDIT UNION OPENS NEW SEWICKLEY BRANCH OFFICE

Moon Township, PA --- January 11, 2008 --- Clearview Federal Credit Union has announced the opening of its newest branch office in Sewickley, PA. This is the sixth branch the credit union has opened since becoming a community credit union. The Credit Union plans to open four more branches this year.

The Sewickley branch will be located at 510 Beaver Street, Sewickley, PA 15143. The office will be open Monday-Thursday from 9:00 a.m.–5:00 p.m., Fridays from 9:00 a.m.–6:00 p.m. and Saturdays from 9:00 a.m.–1:00 p.m. to serve the 12,000 members who reside in the area. The 3,600 square-foot branch will feature ATM and night drop convenience outside of the building.

It will be a full-service branch featuring four teller windows and will offer Clearview's full range of products and services, such as: free checking accounts, a low-rate Visa[®] card, savings accounts, money market accounts, savings certificates, IRAs, and mortgage, education, home equity and auto loans. The new office will also offer a full line of business products and services and will feature electronic banking services and a surcharge-free ATM network.

Mark Brennan, Clearview's President and CEO, believes that the Sewickley area is a natural fit for Clearview. "We've always wanted a branch in the Sewickley area because we have such a strong member base here. Now we can offer our members the convenience of having a branch right in their backyard. "

Mr. Brennan also noted that there are unlimited opportunities for business growth in Sewickley. “Not only is Sewickley ideal for our consumer members, but there are a lot of small-to-medium size businesses in the downtown Sewickley area. We have a full range of services and programs that are an excellent fit for these businesses.”

The new Sewickley office’s branch manager is James Mastroianni. Mr. Mastroianni has over 20 years of experience in the financial industry. Prior to joining Clearview, he worked with several national retail banks. Most recently, Mr. Mastroianni was in charge of 47 retail offices across three states.

Mr. Mastroianni, commenting on his new position said, “I’m excited to come to the Sewickley branch. I’ve been actively involved in the Sewickley community for years, as a founding member of the Quaker Valley Rotary and as a committee member for many of the town’s events. Clearview’s philosophy of personal service will make them an excellent addition to the Sewickley community. I think the residents of Sewickley will find us to be a great community partner.”

Clearview Federal Credit Union is headquartered in Moon Township, PA and is a not-for-profit, member-owned-and-operated, full-service financial institution. It became a community chartered credit union in September 2004, which allows it to offer financial services to anyone who lives, works, worships, volunteers or attends school in Allegheny County and the nine surrounding counties in Southwestern Pennsylvania. Clearview is the largest credit union headquartered in the Greater Pittsburgh Metropolitan area, and the sixth largest such organization in Pennsylvania. It serves approximately 72,000 members and has reported assets valued at \$600 million. Clearview’s other branch offices within Southwestern Pennsylvania include the following locations: Brentwood, Center Township, Monaca, Beaver Falls, McKees Rocks and Pittsburgh, and an out-of-state branch in Charlotte, NC. Clearview Federal Credit Union is federally insured by the National Credit Union Administration and is an Equal Housing Lender.
